### Investment in Musselburgh – June 25

Welcome to our newsletter updating you on Scottish Waters work at Esk Wastewater Pumping Station (WwPS).

**Overview** – Esk WwPS requires a full refurbishment after it experienced pump failure. We have installed temporary pumps which achieves the same operational capability the station requires to maintain essential services.

Our surveys of the building and ancillary equipment have identified complex and extensive work is required to restore the asset and infrastructure. The outstanding construction programme and equipment replacement forecasts a construction presence onsite until **December 25**.

**Progress Update** – the site perimeter has been extended; we upgraded our temporary footpath and erected customer information boards.

The teams on site have been working hard to clean out the station and existing wet wells out-with the station filled with sewerage. You will have noticed large Enviroclean tankers helping us with this task. Once cleaned, the tankers also allowed us to isolate the flows coming into the station and relocate the temporary pumps outside.

This now allows us to investigate and carry out repairs /replacement of the pumps and equipment within the station building.

**Next steps** – while work within the station is underway. We are progressing our plans to reinstate the field we have occupied back to as it was previously.

Throughout August and September, we will be reinstating some of the soft landscaped areas. It is recommended we keep these areas fenced off to allow the grass time to retake, prior to handing back to the Council to maintain.

While our work is ongoing, **there will be no impact to residents' water or wastewater services.**

**We would like to thank the community** for your continued cooperation and support while this essential work is ongoing.
