Why this project is required

The existing treatment works at Tomatin was commissioned in the 1980's and although still in working order, new processes are required to continue to supply clean, fresh drinking water securely into the future.

The current water supply is taken from the existing borehole, treated and supplies around 600 customers.



Scope of Works

- New Water Treatment Works which will take the form of a Transportable Treatment Unit (TTU)
- TTU to be positioned on land next to existing access track
- TTU is constructed offsite and transported to site in sections. This will minimise our time on site
- We will also replace the borehole pump

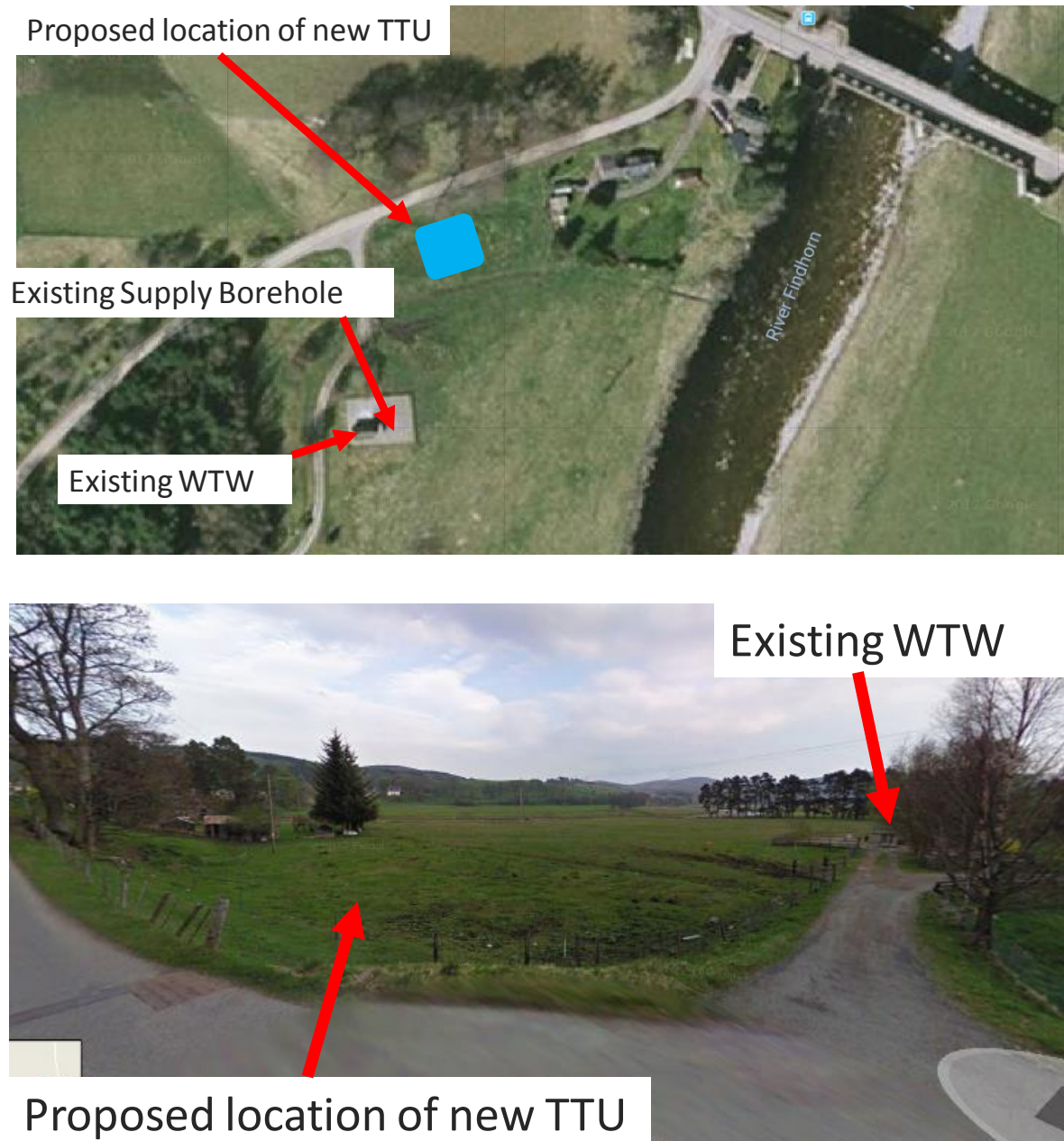

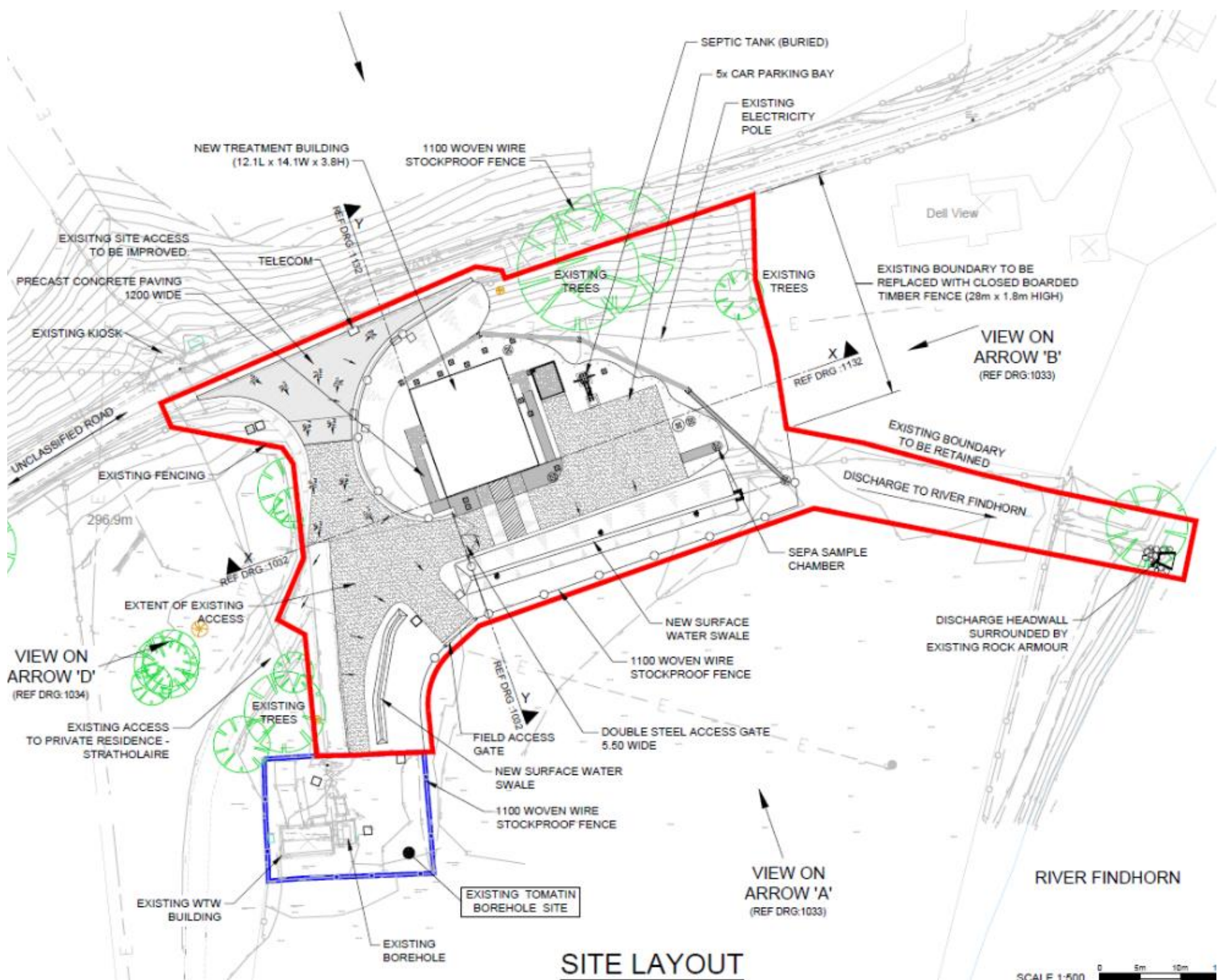

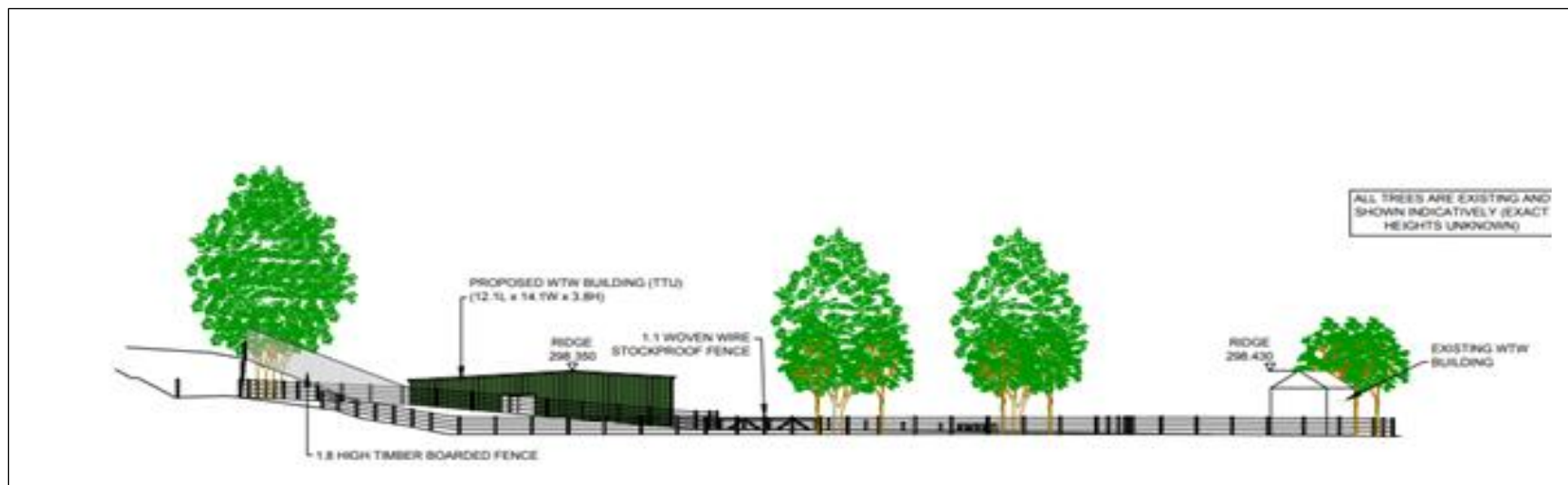

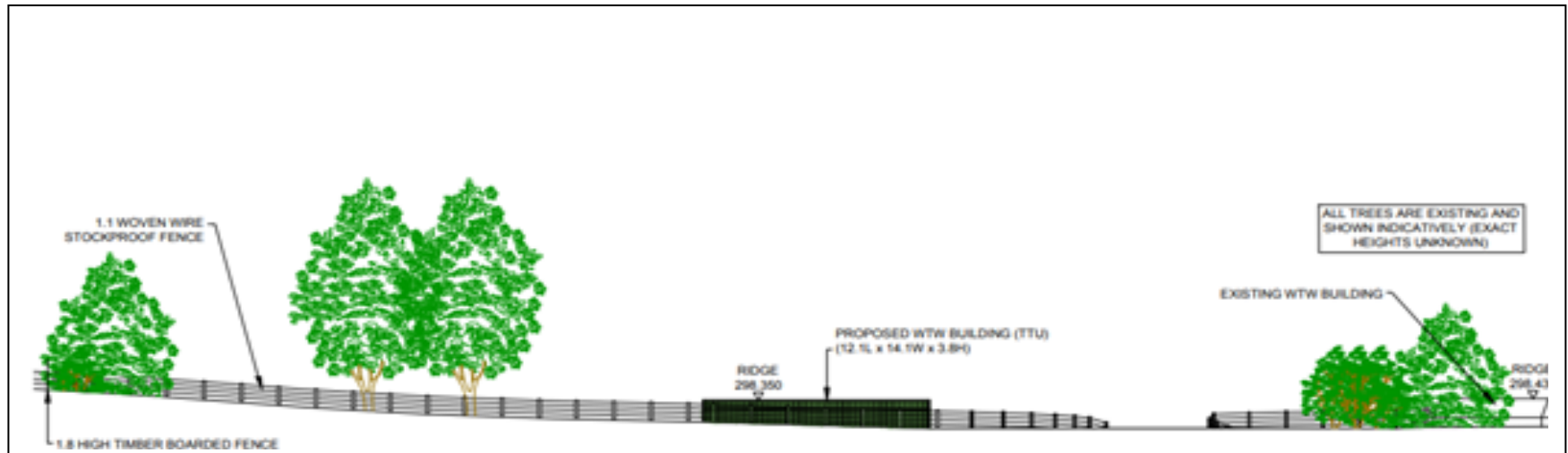
